We hear all the time that many families feel like they can't afford private college, but the truth is that as a private university we offer a wide range of scholarships and grants that allow us to be as affordable or more affordable than state colleges and universities.

This is especially true for Pell-eligible students, which is what the Access to Mside program is all about. In an effort to help you compare your college or university options, we packaged the Access to Mside to make sure you can see and compare how a Morningside education can have a similar cost to what Pell-eligible Nebraska residents who are considering a public in-state college or university would expect to receive.



#### TO QUALIFY FOR THE ACCESS TO MSIDE PROGRAM, YOU MUST:

- Attend or be a graduate of South Sioux City High School (2024 or after)
- Complete the FAFSA and qualify for the Federal Pell Grant\*
- Be admitted to Morningside University\*\*\*\*

#### IF YOU MEET EACH OF THESE REQUIREMENTS, YOU WILL RECEIVE:

- \$37,000/year if you are an on-campus or resident student\*\*
- \$31,000/year if you are an off-campus or commuter student\*\*/\*\*\*

#### TAKE THE NEXT STEPS

- Complete your Application for Admission to Morningside
- Set up a Campus Visit
- Complete your FAFSA AS SOON AS POSSIBLE at studentaid.gov
- Make your Enrollment Deposit

\*Not sure if you are Pell eligible? The Morningside University Office of Financial Planning encourages you to complete the FAFSA to find out. Not only will completing the FAFSA help you determine if you are Pell eligible, but it can also open the door to a variety of other financial aid options. If you have questions or require assistance with this process, please contact our Office of Financial Planning.

\*\*Students who take part in this program will be required to complete the FAFSA each year. Should you no longer qualify for the Pell Grant or the lowa Tuition Grant during that time, the amount of the Federal Pell Grant, Pell Enhancement Grant, Iowa Tuition Grant, and SEOG Grant would be reduced from this amount.

\*\*\*Students who are approved and choose to live off-campus prior to reaching 91 credit hours will receive \$31,000/year.
